## Pricing Policy

### Opening hours:

Monday – Friday from 8.00am – 5.30pm Alternative hours will be considered and if feasible offered by arrangement.

(Nursery is closed for 1 week at Christmas plus bank holidays as listed on our calendar)

### Sessions and pricing:

#### **9 months – 2 year old**

8:00am – 1:00pm	£34.50	Includes a morning snack, lunch and pudding
1:00pm – 5:30pm	£32.50	Includes an afternoon snack, tea and pudding
8:00am – 5:30pm	£64.00	Includes a morning and afternoon snack, lunch and tea with puddings
9:00am – 3:00pm	£40.50	Includes a morning and afternoon snack, lunch and pudding

#### **2– 3 year old (without funding)**

8:00am – 1:00pm	£31.50	Includes a morning snack, lunch and pudding
1:00pm – 5:30pm	£29.50	Includes an afternoon snack, tea and pudding
8:00am – 5:30pm	£58.00	Includes a morning and afternoon snack, lunch and tea with puddings
9:00am – 3:00pm	£37.50	Includes a morning and afternoon snack, lunch and pudding

### **Funded children**

Any children who are using funding for any of their time with us will be subject to the funded children's pricing policy as below.

Funding will be provided to all eligible children, additional funding that is dependent on successful application being made through the government schemes will only be provided once funding codes have been submitted to the nursery for authorisation.

Unfortunately, we cannot facilitate packed lunches/snacks due to lack of refrigeration space and storage.

We believe that all children should have access to our nursery. If your financial circumstances are a barrier to you accessing our provision, then please give us a call and we will be happy to discuss other help and options that may be available to you.

### **2-3 years funded places**

Two-year funding is available subject to the eligibility criteria listed [here](#).

Qualifying children will be entitled to 15 hours of childcare during term time that they can use within any of our set sessions below. Funding can be stretched throughout the 51 weeks we are open if children attend full time.

Meals and snacks are chargeable for each session and any additional hours over and above the 15 hours will be charged at a set hourly rate.

8:00am – 1:00pm	Includes a morning snack, lunch and pudding
1:00pm – 5:30pm	Includes an afternoon snack, tea and pudding
8:00am – 5:30pm	Includes a morning and afternoon snack, lunch and tea with puddings
9:00am – 3:00pm	Includes a morning and afternoon snack, lunch and pudding

### **Additional Costs for Two Year Funding**

Lunch and pudding	£4.30
Tea and pudding	£3.30
Snack	£1.00
Hourly Rate for additional hours above funding	£4.20

### 3 – 4 years funded places

All 3-4 year olds are eligible for 15 hours of funded childcare, with eligibility criteria for an additional 15 hours (to total 30 hours) listed [here](#).

Qualifying children will be entitled to 15 or 30 hours of childcare (dependant on eligibility) that they can use within any of our set sessions below.

Funding can be stretched throughout the 51 weeks we are open if children attend full time.

Meals and snacks are chargeable for each session and any additional hours over and above the 15 hours will be charged at a set hourly rate.

8:00am – 1:00pm	Includes a morning snack, lunch and pudding
1:00pm – 5:30pm	Includes an afternoon snack, tea and pudding
8:00am – 5:30pm	Includes a morning and afternoon snack, lunch and tea with puddings
9:00am – 3:00pm	Includes a morning and afternoon snack, lunch and pudding

#### Additional Costs for Three to Four Year Funding

Lunch and pudding	£7.80
Tea and pudding	£6.55
Snack	£2.50
Hourly Rate for additional hours above funding	£4.20

#### Discounts

- 5% deduction for a full-time place.
- 10% sibling discount shown on the second child's invoice.
- Any ad hoc or additional hours will be charged at our hourly rate of £6.
- For those accessing funded places a 15% discount on food will be provided if a child attends a full 8am – 5.30pm session.

Only one discount from the above can be applied to an invoice.

Please note that **all fees are invoiced monthly and payable in advance** so we appreciate prompt payment. Please speak to the management if you need to discuss late payment of fees.

Unauthorised late payment will unfortunately incur a 5% surcharge. If late payment continues we will be unable to accept the child until the balance has been paid.

Our annual fee increase will take effect from the 1<sup>st</sup> of September.

We accept childcare vouchers and understand that parents may be claiming working tax credits.

#### Holidays, sickness and cancellation:

- Holidays for non-funded children are charged at half fees if one months' notice is given.
- Holidays for funded children will not incur any charges for meals and snacks if one months' notice is given.
- Late collection will be charged at our hourly rate (£6).
- Cancelled sessions will still be charged for i.e. sickness etc
- In event of adverse weather or a situation where the nursery is forced to close we aim to offer alternative sessions or payment will be refunded.

#### Deposit:

- We do not charge a deposit or administration cost; these are all built into our fees.

#### Forest school:

- We believe that all children should have access to Forest School. However, children need to settle fully into nursery life before attending, therefore Forest School sessions will start the term after the child has started at nursery.
- Forest School cost is £27.50 per month per child (excluding August) and will be invoiced monthly.
- This is a set fee regardless of the amount of sessions your child attends over the term, we aim for a minimum of 15 sessions per term, 1-2 sessions per week.

- Tax free childcare is available for working families who earn at least £152 per week. For every £8 you pay into an online account, the government will add an extra £2, up to £2,000 per child per year.
